- Sui generis database laws or copyrights can provide protection to databases.
- Trademarks can protect the names, logos, symbols, and other signs which are posted on websites.
- Industrial Design Protection can be given to screen displays, graphic user interfaces, web pages, and computer-generated graphic symbols.
- Any mark that reflects the name and character of the business can be registered as a trademark.
- Online business methods can be filed for Patent Protection.

- The most important place for prior art search is “worldwide patent system”. Two prior art search processes are present which are a product search and a patent search. The first step is finding a right keyword and special technical terms in order to search for relevant content. They explained the proper keywords such as Rodent trap or mouse trap generate 20,000 vs 700 patent inventions.

- For product searching one need to see whether it is there in market. Products in development but not yet on the market may be prior art, so search news sites, industry journals, trade show and exhibition websites.
- Also inventors can also checks shops, books, periodicals, printed catalogues etc and talk with retailers, suppliers, retired personnel to obtain relevant information on the specific products.

There are several online tools for patent searches in European Patent Office (EPO), WIPO PATENSCOPE, and USPTOList of free patent search engines available.
