The contractor shall ensure that the staff deployed shall carry out the duties specified in Annexure - I diligently.


#### III. DEPLOYMENT

The contractors shall deploy guards from among the staff employed by them as follows:-



#### IV. UNIFORMS


The Contractor shall provide uniforms and monsoon/winter clothing to their staff and ensure that the security staff always wear uniforms and appear presentable while on duty.

9) The Company agrees to provide Stationery, Registers and Forms required for the purpose at its cost.

10) In the event of theft or pilferage of materials or Company's property guarded by the personnel of the Contractor, the company shall immediately register complaints with the police and inform the Contractor to conduct a preliminary enquiry forthwith and send a report to the concerned. The Company shall meet the expenses incurred in this connection; however, it will be the responsibility of the contractor to pursue the matter with the police with the assistance of the Company. Payment of damages, if any, the Contractor will give the guarantee of recovering the property, after scrutiny, if the involvement of security personnel is conclusively proved.

## VII. TERMINATION


- 1) This Agreement can be terminated by One-Month's Notice on either side. In lieu of such notice, the compensation to be paid by the company to the Contractor will be equivalent to One-Month's service charges and vice versa.
- 2) After the expiry of the Agreement Period, the Agreement shall be deemed to have been extended except for necessary Enhancement in Service Charges paid by the Company to offset increase in cost of living or to meet statutory requirements.

## VIII. ARBITRATION

Any dispute or difference or claim arising out of or in relation to this agreement including construction, performance or breach thereof, which the parties cannot settle by reaching a mutual understanding, shall be settled by arbitration. Such arbitration shall be held in Bangalore Jurisdiction Only.


